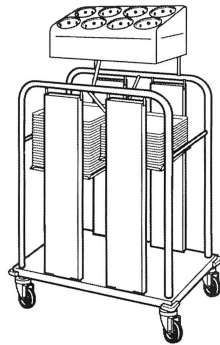

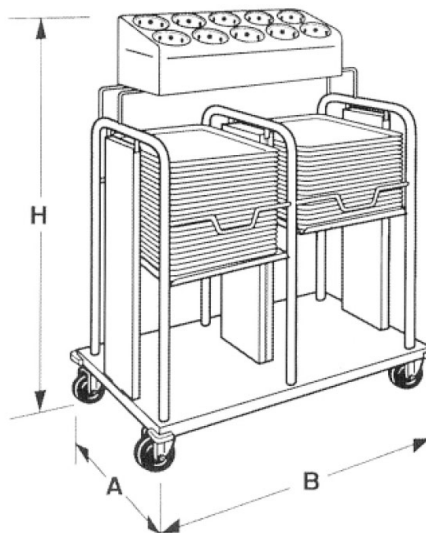
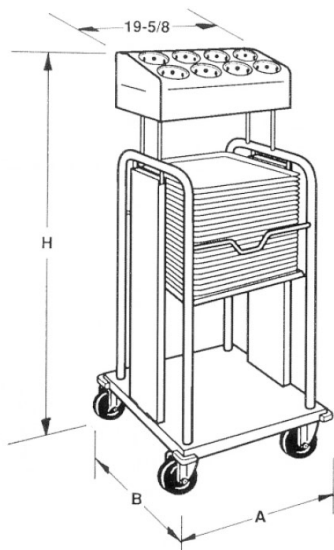

- Top-mounted stainless steel silverware holder (Does not include plastic silverware cylinders.)
- Non-marking bumper attached at each corner
- Four 4" heavy-duty non-marking swivel casters that are securely mounted to the base
